## JUDGE HOLGATE REFUSED OUR APPEAL, REDROW WILL BE MOVING AHEAD WITH BUILDING ON WHITE CROSS/ FARM LANE, CAN THE PARISH COUNCIL COME TO OUR RESCUE ?

# AND CHELTENHAM BOROUGH COUNCIL GO TO PUBLIC CONSULTATION ON THE LOCAL PLAN (part 1), THIS IMPORTANTLY INCLUDES THE LECKHAMPTON LOCAL GREEN SPACE

#### **JUDICIAL REVIEW AT THE HIGH COURT, REDROW 370 ON WHITE CROSS/ FARM LANE** Sorry, really bad news, we lost our appeal with Judge Holgate. The Aarhus Convention has limited our costs to £10,000 but LEGLAG now struggles for survival! In essence, REDROW and Tewkesbury Borough Council have driven a coach and horses through the planning process. The Parish Council's Local Green Space application on White Cross was completely ignored, with no explanation, not one letter from Tewkesbury Borough Council since the application was submitted in July 2013, so much for localism! The greenfield site is not plan led, in fact Inspector Ord has stated that the site is unsound and has the full nine yards of JCS evidence to back up her preliminary and Interim reports. It's the children who have lost out and the community integration just got shoved aside in the pursuit of profit and the new homes bonus. We hope REDROW will see the business sense in working with the community and provide green space, Cheltenham Borough Council objected strongly to this planning application in their two letters. This area is part of Cheltenham but Tewkesbury Officers forced the application through with no thought given to the



communities affected.

What are our options? The judgement can be taken to the Court of Appeal. There are critical errors in the written judgement, for example there was a misunderstanding on the Parish Council's NPPF Local Green Space application and the dates. If we go to the Appeal Court it would be vital to get support from the Parish Council.
